

2023 Part D Coverage of Insulin



POINT OF CARE MEDICARE INFORMATION FOR PROVIDERS

As part of the Inflation Reduction Act passed by Congress, effective Jan. 1, 2023, Wellcare members will not pay more than \$35 for a one-month supply of each insulin product they take. The insulin product must be covered by their Medicare prescription drug plan and must be dispensed by either a local or mail-order pharmacy. The \$35 cap applies to all coverage phases in all Medicare plans. All members are eligible, including those who receive “Extra Help.”
